## Rules:

1. Registry in appropriate breed associations is required for entry.
2. BEEF CATTLE - all females 24 (twenty-four) months of age or older at the beginning day of the fair must : a) have a calf at side; b) show obvious signs of pregnancy; or c) have a veterinarian's certificate of pregnancy. Note: Nurse cows will not be permitted on the fairgrounds.
3. If there is a sufficient number of any one breed, a separate division may be established.
4. All State and Local rules apply.
5. Nurse cows will not be permitted on the fairgrounds.
6. California Cattle - Cattle of all breeds must be from a herd that is not infected with or quarantined for tuberculosis or brucellosis.

4. All females 24 (twenty-four) months of age or older at the beginning day of the fair must: a) have a calf at side; b) show obvious signs of pregnancy; or c) have a veterinarian's certificate of pregnancy.
5. Nurse cows will not be permitted on the fairgrounds.
6. California Cattle - Cattle of all breeds must be from a herd that is not infected with or quarantined for tuberculosis or brucellosis.
